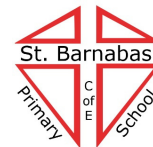

Job Description for KS2 (Y6) Teacher



Salary: The post holder will be paid on the appropriate point of the main scale /UPS, dependent on experience.

Line management

The teacher is responsible to the Headteacher through the school's line management structure.

Job content

Basic duties

- The basic duties of a teacher are outlined in the latest School Teachers' Pay and Conditions Document.

Job purpose

- To teach and care for the pupils assigned to you as a classroom teacher, compliant with the school aims and in pursuit of high standards of pupil achievement – academically and socially. The school aims to create an environment which stimulates learning, is individually rewarding, dynamic and safe.

Objectives

- To ensure pupil entitlement to the national curriculum.
- To create a classroom atmosphere conducive to effective learning.
- To help all pupils achieve and realise their potential.
- To ensure that all pupils observe the code of conduct.

Main responsibilities

Adhere to all school policies appertaining to:

- Classroom management, including issues of health and safety.
- Planning and delivery of the curriculum
- Target setting.
- Marking, assessing, recording and reporting.
- Pastoral care.
- Carrying out supervisory duties in accordance with published schedules and procedures and maintain professional credibility at all times.
- Be proactive in personal professional development.

Key tasks

- Teach pupils within the primary school age range in the role of class teacher
- To record and monitor pupils achievements - to maintain satisfactory records in accordance with N.C. Requirements.
- To identify, along with other staff, children with additional needs or Special Educational Needs and to inform the appropriate inclusion manager.
- Be proactive in reporting child protection/safeguarding concerns to the named person
- Fully use agreed curriculum policies/ schemes of work and the staff handbook.
- Attend and contribute to key stage, team and full staff meetings.
- Consult with colleagues and / or senior staff when guidance/advice is required.

- Contribute towards the goals and targets in the school's strategic plan.
- To report to parents as required and to consult with parents regarding the educational needs and progress of their children.
- To supervise the work of ancillary support staff as required and to supervise students when necessary.
- Ensure that punctuality and effectiveness are observed at all times.
- Maintain high standards of personal conduct and dress.
- Maintain a professional interest in educational initiatives relevant to your subject(s).
- Consult with senior staff, appraiser and staff development co-ordinator on any issue relevant to personal professional development, in line with the school's strategic plan.

Conditions of employment

The above responsibilities are subject to the general duties and responsibilities contained in the written statement of conditions of employment (the Contract of Employment).

The post holder is required to support and encourage the school's ethos and its objectives, policies and procedures as agreed by the governing body.

To uphold the school's policy in respect of child protection matters.

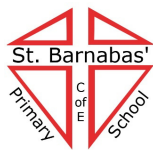
S/he shall be subject to all relevant statutory requirements as detailed in the most recent School Teachers Pay and Conditions Document.

This job description allocates duties and responsibilities but does not direct the particular amount of time to be spent on carrying them out and no part of it may be so constructed.

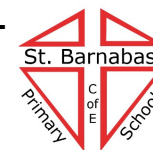
This job description is not necessarily a comprehensive definition of the post. It will be reviewed at least once a year and it may be subject to modification at any time after consultation with the post holder.
